It is specifically agreed that TAR HEEL kids Wrestling Club and the University of North Carolina shall not be responsible or liable to the wrestler and/or parent/guardian for articles lost or stolen at the club training facility (University of North Carolina Wrestling Room – Fetzer Gym). TAR HEEL kids Wrestling Club and the University of North Carolina shall not be responsible or liable for loss or damage to any other property of the wrestler and/or parent/guardian including but not limited to their automobile(s) and contents thereof. It is also agreed that any damages to the program training facility (University of North Carolina Wrestling Room – Fetzer Gym) or property of any wrestler and/or parent/guardian by any other wrestler and/or parent/guardian, is the sole responsibility of the offending wrestler and/or parent/guardian.
